# AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MAPLEWOOD, MISSOURI CALLING A BOND ELECTION IN THE CITY OF MAPLEWOOD, MISSOURI

WHEREAS, the City Council of the City of Maplewood, Missouri (the "City") finds it necessary and hereby declares its intent to borrow \$6,000,000 for the purpose of constructing, reconstructing, extending, repairing and improving city streets, sidewalks, and street lighting (the "Project") and to evidence such borrowing by the issuance of general obligation bonds of the City in the amount of \$6,000,000;

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MAPLEWOOD, MISSOURI, AS FOLLOWS:

**Section 1.** A special bond election is hereby ordered to be held in the City on April 2, 2024, on the following proposition:

#### PROPOSITION S

Shall the City of Maplewood, Missouri, issue its general obligation bonds in the amount of \$6,000,000 for the purpose of constructing, reconstructing, extending, repairing and improving city streets, sidewalks, and street lighting?

The authorization of the bonds will authorize the levy and collection of an annual tax in addition to the other taxes provided for by law on all taxable tangible property in the City sufficient to pay the interest and principal of the bonds as they fall due and to retire the same within twenty years from the date thereof.

- **Section 2.** The form of the Notice of Bond Election for said election, a copy of which is attached hereto as **Exhibit A** and made a part hereof, is hereby approved.
- **Section 3.** The City Clerk is hereby authorized and directed to notify the Board of Election Commissioners of St. Louis County, Missouri, of the adoption of this Ordinance no later than 5:00 p.m. on January 23, 2024, and to include in said notification all of the terms and provisions required by Chapter 115 of the Revised Statutes of Missouri, as amended.
- **Section 4.** The City expects to make expenditures on and after the date of adoption of this Ordinance in connection with the Project and the Police Project, and the City intends to reimburse itself for such expenditures with the proceeds of the bonds. The maximum principal amount of bonds expected to be issued for both projects is \$6,000,000.
- **Section 5.** The Mayor, the City Clerk, the Finance Director and other officers and representatives of the City are hereby authorized and directed to take such other action as may be necessary to carry out the purpose and intent of this Ordinance.
- Section 6. This Ordinance shall be in full force and effect fifteen (15) days after its passage and approval.
