Design and Review Board Meeting Minutes Thursday, April 11, 2024

- 1. Call to Order/Roll Call: The meeting was called to order at 6:00 p.m. Present were Lisa Griffin, Mary Killian, Sean O'Gorman, members excused Dana Valenti, Lauren Savel. Staff present: Brian Herr.
- 2. Approval of the meeting minutes from March 14, 2024: Sean O'Gorman made a motion to table the minutes due to the lack of members present.
- 3. Review and recommendations for the following applications:
 - 1. **2025 Bellevue Ave. rear covered deck:** Josiah Green presented elevation plans of the proposed pergola. Josiah described the structure and the attachment to the deck. Member Sean O'Gorman asked about the height and the color of the pergola. Josiah indicated the height and color of the manufactured pergola kit. Sean O'Gorman made a motion to approve and motion was seconded by Mary Killian. All were in favor, motion passed.
 - 2. **2849 Laclede Sta. Rd. rear covered deck:** Nancy Schick and Kent McLain presented plans and elevations of the proposed rear covered deck. Nancy described the current deck construction and the proposed rear covered deck and the materials. Member Sean O'Gorman asked about the railing system to be used around the top uncovered second story portion. Nancy provided a detail of the railing system and the manufacturers literature and photo. Member Sean O'Gorman asked about the basement staircase and the south side of the deck. Nancy indicated that the basement stairs are covered and the cover is to remain. Member Sean O'Gorman made a motion to approve as submitted and was seconded by Lisa Griffin. All were in favor, motion passed.
 - 3. **7270 Manchester Ave. Zee Bee Market projecting sign:** No one was present to present the proposed projecting sign. Agenda item was tabled.
 - 4. **REVISED 7520 Manchester Rd. Revel Kitchen ground sign and window display sign:** No one was present to present the proposed ground sign and window display sign. Sean O'Gorman made a motion to approve with the stipulation that the ground sign have white or blue lettering and motion was seconded by Mary Killian. All were in favor, motion passed.
 - 5. **7570** Lohmeyer Ave. Maplewood Family Aquatic Center wall sign: City staff Brian Herr presented a rendering of the proposed signage. The Board discussed options for the signage. Member Sean O'Gorman suggested that the lettering be larger to match the scale of the front of the building and be mounted higher that what was shown on the rendering provided. Member Mary Killian asked if some other options with different fonts and possibly city or aquatic center logo be provided.
- 4. Adjournment: Member Sean O'Gorman made a motion to adjourn, seconded by Lisa Griffin and all approved. The meeting adjourned at 7:30 p.m.





Front porch for the house located at 7415 Elm Ave.







Awning sign message max length: 162" x 0.75 = 121.5" wide max

Door Glass: 27" x 58" = 1,566 / 144 = 10.875 sqft Left Window: 44"x 77" = 3388 / 144 = 23.52 sqft Right Window: 45" x 77" = 3465 / 144 = 24.06 sqft total glass area: 58.455 sqft Window Sign max area: 58.455 x 0.15 = **8.765 sqft** Awning logo and lettering length: 121" Awning capital letter height: 5.2"
